3. The scholarship will be paid @ Rs. 800/-P.M. (enhanced) for 10 months on the basis of merit-cum-means.
4. Two scholarships of the value of Rs. 1000/-p.m. each for 10 months be awarded to the girl students in Medical College affiliated to the Panjab University strictly on the basis of merit-cum-means.
5. The scholarships be awarded by a committee to be constituted by the Vice-Chancellor which may include Dr. G.K.Rakkar of Nawanshehar.
6. If two or more students obtain the same percentage of marks the amount of the scholarship be distributed equally amongst them.



**REGULATIONS RELATING TO THE AWARD OF THE SCHOLARSHIPS KNOWN AS PANJAB UNIVERSITY SOLDIER'S RELIEF FUND SCHOLARSHIP.**

1. Two scholarships will be awarded every year to the sons & daughters of members of Defence service studying at the Panjab University Department/College, preference will be given to the children of those who are disabled or have been killed in Military operations.
2. Each scholarship shall be of the value of Rs. 400/-p.m. for 10 months
3. The tenure of the scholarship shall for the duration of course to which a student is admitted, i.e. two or three years as the case may be.
4. ~~No students shall be hold a scholarship under these regulations alongwith another scholarship without the approval of the Vice-chancellor~~
5. A student who has been awarded scholarship under these regulations shall be liable to pay the tuition fee to the deptt./college for the months for which the scholarship is claimed. This, however, shall not debar him/her from grant of full or half fee concession by the deptt./college.
6. Scholarship shall be awarded to the express understanding that the holder shall attend the deptt./college as a regular student & pursue his/her studies with industriously if it should appear at any time that scholars fail to make satisfactory progress or has been guilty in gross misconduct/attendance, he shall after due warning, be reported by the Chairman/Principal of University/Deptt./College to the Vice-Chancellor who may diminish or withdraw the scholarship.
7. A scholarship shall be awarded by the Vice-Chancellor on the recommendations of a committee to be appointed by him.

**RULES REGARDING AWARD OF STIPENDS OUT OF LATE DEWAN SOM NATH & LATE RADHA KRISHAN PREM KAUR.**

1. The stipends may be called 'Late Dewan Som Nath/Late Radha Krishan Prem Kaur stipends. These shall be financed from the income of the endowment Bequeathed by the donor to the University.
2. There will be '25' Late Dewan Som Nath Scholarship @ Rs. 400/- p.m. each & '10' Late Radha Krishan Prem Kaur stipends @ Rs. 150/- p.m. each.
3. The ten stipends known as Late Radha Krishan Prem Kaur stipends shall be awarded to the student of B.A.I class only and 25 stipends known as 'Late Dewan Som Nath' shall be awarded to the students studying at the Panjab University Teaching deptt./affiliated colleges on the basis of merit-cum-means.
4. The tenure of the stipends/scholarship shall be for ten months.
5. The stipends shall be awarded to the students (registered with P.U., studying at the Panjab University Teaching Deptt./ affiliated college on basis of merit-cum-Means. (Rule amended vide Syndicate, para 5 dated 15.7.95.)
6. Notwithstanding the facts student is already in receipt of University or Govt.scholarship. He/she shall be eligible for consideration for the award of stipend under these rules.
7. A student who has been awarded stipend shall be liable to pay tuition fee to the Teaching Deptt/ College for the months for which stipend is claimed. This however, shall not debar him from availing himself of full/half fee/concession if granted by the Deptt./College.
8. The stipend shall be awarded on the express understanding that the holder shall attend the Deptt./College as a regular student and pursue his studies Industriously. If it appears at any time that the scholars has failed to make satisfactory progressor has been guilty of gross misconduct or laziness or has been irregular in attendance he shall after due warning be reported against by the Head of the University deptt./college to the Vice-Chancellor who may, if he deems fit reduce or withdraw the stipend.
9. A stipend holder who has not fully cleared the previous University examination shall not be eligible for this stipend again.
10. The stipend shall be awarded by the Vice-Chancellor on the recommendation of the committee appointed by him.
11. The students are required to send the affidavit of annual income from all sources duly attested by the Competent Authority, which means the Tehsildar, Distt. Magistrate or the Employer.

1. The stipends may be called 'Late Dewan Som Nath/Late Radha Krishan Prem Kaur stipends. These shall be financed from the income of the endowment Bequeathed by the donor to the University.
2. There will be '25' Late Dewan Som Nath Scholarship @ Rs. 400/- p.m. each & '10' Late Radha Krishan Prem Kaur stipends @ Rs. 150/- p.m. each.
3. The ten stipends known as Late Radha Krishan Prem Kaur stipends shall be awarded to the student of B.A.I class only and 25 stipends known as 'Late Dewan Som Nath' shall be awarded to the students studying at the Panjab University Teaching deptt./affiliated colleges on the basis of merit-cum-means.
4. The tenure of the stipends/scholarship shall be for ten months.
5. The stipends shall be awarded to the students (registered with P.U., studying at the Panjab University Teaching Deptt./ affiliated college on basis of merit-cum-Means. (Rule amended vide Syndicate, para 5 dated 15.7.95.)
6. Notwithstanding the facts student is already in receipt of University or Govt.scholarship. He/she shall be eligible for consideration for the award of stipend under these rules.
7. A student who has been awarded stipend shall be liable to pay tuition fee to the Teaching Deptt/ College for the months for which stipend is claimed. This however, shall not debar him from availing himself of full/half fee/concession if granted by the Deptt./College.
8. The stipend shall be awarded on the express understanding that the holder shall attend the Deptt./College as a regular student and pursue his studies Industriously.
